The transaction(s) concluded within the framework of the Transaction, i.e. the share repurchases, will be executed in accordance with Article 23 of Regulation (EU) No 600/2014 of the European Parliament and of the Council of 15 May 2014 on markets in financial instruments and amending Regulation (EU) No 648/2012 (**MiFIR**), within the framework of FIX transactions specified in the BSE General Terms of Service, taking into account the minimum value for FIX transactions concluded under the Large In Scale (LIS) waiver, which at the time of this publication is **HUF 30,000,000, i.e. thirty million Hungarian forints**.

The execution of the Transaction and its terms and conditions remain unchanged, except for the minimum value of **HUF 30,000,000, i.e. thirty million Hungarian forints**; the [extraordinary announcement](#) published on 24 March 2026 shall continue to be applicable in this respect.
